LILO FORE, FEI 5* ret, USEF "S" Judge, active trainer, clinician and competitor, who trains horses and riders through Grand Prix in Dressage at her training farm, Sporthorse America, in Santa Rosa California. Lilo has been a member of the Ground Jury for numerous USET Selection Trials for the Pan American Games, the World Equestrian Games and the Olympics. Originally from Dusseldorf Germany, her dressage journey began at the age of four when she saw her first horse, and continued through the Grand Prix level in Dressage. She was shortlisted for the USET in 1976 on her horse Dionysus, and continues to ride and train horses and riders of all levels. *Rider sessions may be semi-private and will focus on correct basic work & systematic development/ training with special emphasis on suppleness and harmony for each individual horse and rider.*

CLINIC AGREEMENT/RELEASE

If I am a minor under eighteen (18) years of age, a parent or guardian shall sign on my behalf. **All riders ride at his/her own risk. Safety helmets are required when riding at all times** and are the responsibility of the rider. Organizers assume NO LIABILITY for Applicant and his/her horse or personal property.
